#### Research Interests

My current research interests focus on adventure education, adventure tourism, experiential education, and how these might intersect with sustainable practices. As of yet I have not conducted research in this area.

Two additional research interests of mine that go hand in hand are Youth Development and Youth Leadership. Thus far I have formulated and carried out a program evaluation for the Boy Scouts of America's High Adventure Program. Two goals of these research projects were to determine whether leadership was being instilled in youth via the High Adventure Program and to determine what elements of this program were promoting leadership or detracting from leadership.

A fourth research interest involves experiential education and outdoor education. My work with the Public Lands Service Coalition and with the time diary pilot study have given me the opportunity to evaluate how participants interact with the outdoors in out of school time and during structured programs with a conservation corps.

RST 120: Foundations of Recreation Spring 2017

Class Size: 40 students

RST 120 provides students with a depth of historical, theoretical, and practical information about the field of parks and recreation. Through this course, students gain proficiency in several recreation-related topics and develop a deeper understanding of the role of recreation in community planning processes. Students will also become familiar with current research topics that draw on disciplines such as psychology, sociology, and landscape architecture. The emphasis in this class is on learning about the major tenets of recreation through analysis of reading material, in-class discussions, and exams.

#### RST 217: Public Recreation

Fall 2016

Class Size: 30 students

RST 217 examines the public sector and its role in the provision of local park and recreation services. Students explore its philosophical foundations, organizational structure, policy-making process, and the administrative tasks of public recreation providers. This course seeks to develop a deeper understanding of the role of public recreation in the lives of people and the practical functions required to facilitate professional roles.

#### RST 420: Human Resource Management in RST

Fall 2016, Spring 2017

Class Size: 40-50 students

RST 420 focuses on the key elements within Human Resource Management. Managing people and working collaboratively with colleagues is a key element of any recreation, sport or tourism organization. In this class students explore concepts, principles and objectives of supervision, the nature of the supervisory relationship, and supervisory functions and processes. Furthermore, students

learn to identify and apply methods and techniques related to human resource management. Finally, students discuss organizational and operational patterns of personnel administration in recreation, sport and tourism settings.

RST 480: Orientation to Practicum

Fall 2016, Spring 2017 Class Size: 50- 55 students

RST 480 prepares and assists in placing students in the 12 credit RST Internship (RST 484). Students must document completion of 300 hours of field work. Topics include placement requirements and policies, resumes, cover letters, reference solicitation, and the role and issues of professional practice. RST 480 is a senior seminar class designed to help introduce students to concepts which are critical to success in the internship (RST 484) and beyond. Additionally, pertinent previous course content is reviewed including academic policies, application materials, goals and objectives, business etiquette, and professional communication

RST 484: Practicum

Fall 2016, Spring 2017, Summer 2017

Class Size: 10-55 students

RST 484 (the internship course) requires students to complete a minimum of 12 weeks in a full-time capacity (40 hours per week) placed with an agency that relates to their major. The course is designed to enhance the internship experience by leading students through practical steps that empower them in the learning/working experiences, practice skills and concepts presented in academic classes, explore areas of personal and professional interest, and by introducing problem and conflict solving techniques.

KIN 107: Aquatic Sport Activities (Guest Instructor for Log Rolling course content) Spring 2016, Fall 2016, Spring 2017

Class Size: 35-45 Students

KIN 107 is focused on skills and knowledge essential for leisure-time activities which are classified as aquatic sport activities.

RST 100: Society and Leisure

Fall 2013, Spring 2014, Fall 2014, Fall 2015, Spring 2016

Class Size: 180-250 Students

RST 100 examines central issues in defining leisure. Historical, philosophical, sociological, psychological, and economic approaches to understanding leisure behavior, its meanings, social contexts, and personal and social resources are examined. By the end of the semester, students should understand the history and evolution of leisure, as well as its impact on contemporary society.

RST 110: Leisure Service Delivery

Spring 2014, Fall 2014

Class Size: 65-130 Students

RST 110 Introduces students to the concepts, principles, and practices related to the provision of leisure services; description of the various fields of professional

practices and central characteristics such as customer service, customer attributes, pricing, and management.

RST 199: Sport and Sustainability Travel Study

Summer 2014, Fall 2015 Class Size: 25- 30 Students

RST 199SS examines the role of sustainability in sport organizations, ask students to develop their own perspectives on controversial topics, and provides opportunities to examine the linkages found in nature and those connecting economic systems, the environment, and society at large.

RST 199: Adventure Recreation and Tourism in New Zealand Travel Study

Class Size: 16 Students

RST 199NZ Explores several aspects of adventure recreation and tourism to understand it from perspectives of both the tourist and the host community. The course orients students to reasons for people to travel to exotic and remote locations to step outside their comfort zone. The activities require a significant effort and involve a degree of risk and perception of danger, and at the same time, a learning of new skills is required to participate in the activities. Because adventure recreation and tourism often takes place in rural areas, the tourist enterprises are usually focused on sustainability and partnerships with local organizations and people.

RST 199: International Tourism for Economic Development Travel Study

Fall 2015

Class Size: 16 Students

RST 199FJ explores ways that tourism is used for economic development in a developing economy to gain an understanding of how international tourism for development is addressed in the Fijian context. The experiential education focuses on learning through guided action. 70% of the students' time is spent visiting Fiji's primary tourism attractions, including beaches, reefs, and resorts under the guidance of knowledgeable field professionals. Some activities require a significant effort and involve a degree of risk and perception of danger, and at the same time, will require learning new skills to participate in the activities.

RST 300: Leisure Programming

Spring 2015

Class Size: 40 Students

RST 300 provides a basic understanding of theory and practice in recreation program development in various service settings. It covers fundamental programming models, goals, program implementation, and evaluation.

RST 341: Community Recreation Planning

Spring 2015

Class Size: 20 Students

RST 341 primarily focuses on: The outdoor recreational use of lands in the public domain and their planning, concepts, and processes related to planning resource based systems; multiple-use in planning; planning criteria for outdoor recreation facilities. This course seeks to develop a deeper understanding of the role of recreation in community planning processes. Literature reflective of current

research and past trends in leisure, psychology, sociology, urban planning, and landscape architecture, among others is incorporated.

RST 370: Research Methods and Analysis

Fall 2013

Class Size: 63 Students

RST 370 is designed to provide a comprehensive introduction to the basic concepts of research methods and statistical analysis. The course provides a conceptual map of science, the research process, and some of the vocabulary, principles, and methods of statistics and analytical techniques. Upon completion of this course, students should have an understanding of the scientific process such that research can be conducted, understood, interpreted, and critically evaluated. In addition, students should be capable of conducting research and have gained the expertise to read and understand resource materials for application to practical research problems.

RST 420: Human Resource Management

Spring 2016

Class Size: 41 Students

RST 420 focuses on the key elements within Human Resource Management. Managing people and working collaboratively with colleagues is a key element of any recreation, sport or tourism organization. In this class students explore concepts, principles and objectives of supervision, the nature of the supervisory relationship, and supervisory functions and processes. Furthermore, students learn to identify and apply methods and techniques related to human resource management. Finally, students discuss organizational and operational patterns of personnel administration in recreation, sport and tourism settings.

RST 429: Contemporary Issues in Recreation, Sport, and Tourism

Fall 2015

Class Size: 62 Students

RST 429 provides a capstone experience for upper-level RST students to discuss contemporary issues in leisure services. Students will investigate different things happening in the world today that affect leisure behavior, such as cellphones, climate change, and helicopter parenting. Students will also discuss how leisure management and delivery is responding to these global happenings.
